ORDINANCE No. <u>RU 2021 - 04</u>

An ordinance levying taxes for all road purposes for <u>RUTLAND</u> Township Road District, <u>KANE</u> County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of <u>RUTLAND</u> Township, <u>KANE</u> County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of <u>RUTLAND</u> Township Road District on <u>December 14</u>, 2021 does hereby determine and declare that the sum of <u>Five hundred</u> <u>fifty-nine thousand one hundred thirty-two and no/100</u> Dollars (\$ 559,132.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
