The Rutland Township Board held its regular monthly meeting in the town hall. Supervisor Bulmahn called the meeting to order at 7:00 p.m. and then asked Clerk Carlsen to lead us in the Pledge to the Flag. Roll call showed the following members present: Supervisor Bulmahn, Clerk Carlsen, Trustees Tessendorf, Stelford, Brown and Schuldt. Assessor Siers, Road Commissioner Schultz, and Sergeant Grimes from Kane County were also present.

SUPERVISOR'S ANNOUNCEMENTS

The Supervisor noted the updated reports on the continued reduction of our levy rates over the past eight years. We've hired a new Bookkeeper, Claudia Tuley, who's an accountant and we're happy to have her on board. Notification from the Village of Gilberts has been received regarding their proposed TIF District of 240 acres within the Village. It is on the table for anyone interested. A reminder to the Board that the annual salary survey from TOI is in this month's TOI Perspective magazine. The deadline for determining salaries for the next term of elected officials is October and the TOI information may be helpful for these determinations. If any benefits were to be included that would also need to be determined. Supervisor Bulmahn also stated that the IRA Plan has been activated for the Town. The Road has already been participating and two employees in the Assessor's office are now eligible. We will need to go before the Kane County Board for a variance for our proposed new sign due to our limited area for placing the sign. This process will probably take another 45 days. It appears that the County will not be splitting the precincts opting to do, what they call, voting centers instead. The audit is proceeding nicely and we hope to have a draft sometime next week. We also have a new landscaper for the cemetery and he seems to be doing a nice job.

Sergeant Grimes from the Kane County Sheriffs Dept. then presented the May monthly statistics for Rutland Township. The Board thanked him for the information and for coming.

EMPLOYEE HEALTH BENEFIT PLAN – RESOLUTION TO ADOPT

A lengthy explanation by the Supervisor followed explaining the four different medical plans available for the Board to consider. Following that, some discussion ensued and it was determined that the "Medical Reimbursement Plan" for both the Town and Road was the best choice. Trustee Tessendorf noted that the Rutland/Dundee Fire Dept. has a Medical Reimbursement Plan and it works very well for them. The Supervisor advised that our Attorney look over the final paperwork on any plan selected. Trustee Brown inquired as to the limits for the reimbursement plan and was told that they would need to be determined by the Board. **A conceptual motion was then made by Trustee Tessendorf and seconded by Trustee Brown to adopt a Medical Reimbursement Plan, or Option 1, for Rutland Township, both Town and Road, for all eligible employees. Maximum benefits and full time hours are yet to be determined.** In discussion, the Assessor noted that her employees would not be eligible as the plan stipulates a full time employee must work 35 hours to be eligible. Her employees only work 30 hours. Vote: Roll call vote.

The discussion continued on the number of hours to be considered as full time and the maximum benefit per month per employee. It was noted that since we're just starting these benefits we need to be conservative and see how it goes till next years budget. **A motion was made by Trustee Brown and seconded by Trustee Tessendorf to modify the previous motion stating that 35 hours per week is to be considered a full time employee and that the maximum health benefit per month will be \$500.00.** Vote: Roll call vote.
