

**TAX LEVY ORDINANCE**  
**TOWNSHIP**  
**ORDINANCE No. RU2020 - 04**

An ordinance levying taxes for all town purposes for RUTLAND Township,  
KANE County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of RUTLAND Township,  
KANE County, Illinois, as follows:

SECTION 1: That the sum of Three-hundred seven thousand one-hundred twelve and no/100 Dollars (\$ 307,112.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

<u>General Town Fund</u>	<u>\$ 306,062.00,</u>
<u>General Assistance Fund</u>	<u>\$ 1,050.00,</u>
<u>Total Funds</u>	<u>\$ 307,112.00,</u>

for the year 2020,

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of KANE, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

ADOPTED this 8<sup>th</sup> day of December, 2020, pursuant to a roll call vote by the Board of Trustees of Rutland Township, Kane County, Illinois.
