ORDINANCE No. <u>RU 2020 - 05</u>

An ordinance levying taxes for all road purposes for RUTLAND Road District,

KANE County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of <u>RUTLAND</u> Township, <u>KANE</u> County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of <u>RUTLAND</u> Road District on <u>December 8</u>, 2020 does hereby determine and declare that the sum of <u>Five hundred thirty-two thousand five hundred seven and no/100</u> Dollars (\$ 532,507.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
