**TAX LEVIES FOR 2008 TAXES COLLECTIBLE IN 2009**

A complete set of documents including the Levy Certification of Compliance, the Levy Summary, the Levy Ordinance and Summary with a preliminary budget detail has been included in the Trustees notebooks this month. The levies for both the Town and Road provide for a 4% increase, which falls within the Cap set by the County. There being no questions or comments **a motion was made by Trustee Schuldt and seconded by Trustee Stelford to approve Ordinance #RU2008-11 being the Tax Levy Ordinance for the Rutland Township Town Fund for the property tax year 2008**

to be collectible in the calendar year 2009. This to be broken down between the General Town Fund of \$245,700, the General Assistance Fund of \$4,400 for a total Levy of \$250,100 with details attached. Vote: Roll call vote.

Once again the same set of documents, but with the Road Fund amounts, has been given to the Trustees for the Road Fund Levy and provides for a 4% increase, which falls within the Cap set by the County. **A motion was then made by Trustee Schuldt and seconded by Trustee Stelford to approve Ordinance #RU2008-12 being the Tax Levy Ordinance for the Rutland Township Road District in the amount of \$432,000. Broken down between the Permanent Road Fund of \$338,000, the General Road & Bridge Fund of \$4,000 and the Equipment Fund of \$90,000 for a total of \$432,000 all being within the 4% Cap set by the County.** Vote: Roll call vote.
